Re: Supporting Students & Staff at Historically Black Colleges & Universities

Dear Secretary Cardona,

Since the start of Black History Month, Historically Black Colleges and Universities (HBCUs) nationwide have come under attack from dangerous white supremacist threats of violence. As a result, several HBCUs have pivoted to remote learning to avoid putting students and staff at greater risk. Although the Biden administration has acknowledged the FBI's law enforcement investigation, the support for HBCUs and their students has been inadequate to date. On behalf of Rise and the undersigned HBCU students and student groups, we call on the Biden Administration to immediately deploy Project SERV grants and other funding resources to help HBCUs better support their students during this difficult time. Specifically, HBCUs need additional resources to provide:

threatened simply for attending HBCUs.
Additional security and campus safety measures to protect students, staff and campuses from bomb threats and other racist violence.
Support for students who have transitioned into remote learning environments to maximize their educational opportunities while away from campus.
Funding to restore safe and vibrant campus environments for students in the aftermath of bomb threats through campus programming and student activities funds.

☐ Emergency counseling and psychological support to students who have had their lives

White supremacist threats to HBCU students are more reminiscent of the 1950s and 1960s than what students should have to expect in 2021. While racism seeks to derail Black students, we expect the Biden Administration to immediately offer resources that protect HBCU students and their campuses and allow them to return to a sense of safety and normalcy. The FBI and law enforcement agencies must bring the perpetrators of these crimes to justice, but law enforcement



is not a sufficient solution to white supremacist violence. HBCUs also need additional funding to support their students in this difficult time, and should not have to draw from already inequitable resources to do so. The Biden administration must step up and take a leadership role in providing these resources for HBCU students and staff to get back on track as soon as possible.
